Free Instrument Exchange Policy

There is no charge for changing instruments. As long as the exchange is within the **30 Month Contract Period** it is possible to exchange for another beginner instrument in comparable condition offered on the payment plan. All payments made will apply towards the 2nd instrument. (Example: Clarinet for Alto Sax; Trumpet for Trombone)

String Instruments: Size changes for string instruments (violins, violas, & cellos) will be made at no additional charge for a string instrument.

Making Your Monthly Payments

The monthly payment is the same for the entire length of the 30 Month contract. At the end of the 30 month period, assuming payments are up to date, the account will be Paid In Full. A coupon book will be mailed showing the payment amount due and due date for each month. Payments are to be received by the 5th of each month.
